Jcr 2024 impact factor

The 2024 Journal Citation Reports has been released, providing the impact factor for journals in 2023. Notably, it consolidates ranking system. Journals now fall under 229 categories with unique quartile values. In 2023 we changed how the Journal Impact Factor (JIF) is shown - moving from three decimal places to one. This change made it so there are more ties in JIF rankings, which means people have to look at other things like what a journal says about itself and why it's good when comparing journals. Our goal of being transparent and trustworthy will continue with the new Journal Citation Report (JCR) coming out in June 2024. Two big changes that we told everyone about last year are going into effect in the JIF rankings for categories. We're moving for all our 229 science and social science categories. Instead of having a different ranking for when something is in Science Citation Index - Expanded (SCIE) or Social Sciences Citation Index (SSCI), we'll have just one ranking that includes everything. For example, the Psychiatry category is in both SCIE and SSCI right now, so we make separate rankings for each edition. We're going to stop doing that and just have one Psychiatry ranking that includes journals from all three. This will give a clearer view of how well a journal is doing in its category. Usually, ESCI journals have lower JIFs because they didn't pass the four impact criteria like SCIE or SSCI journals with higher JIFs than SCIE or SSCI journals. The reason for this is that passing our four impact criteria isn't just about a journal's JIF at one moment - it also depends on whether they pass those criteria. Also, we stopped doing impact evaluations in 2022 to focus on making sure Web of Science doesn't have bad content and so we can do quality evaluations in 2022 to focus on making sure Web of Science doesn't have bad content and so we can do quality evaluations of journals that submit or are already indexed. We're not going to make JIF rankings for arts and humanities categories because our data shows that citations in those fields are a lot slower and lower than in science or social sciences. If we made JIF rankings for those categories, it would create ties and very skewed quartile distributions. Our analysis with various experts from the academic community revealed a consensus that introducing Journal Impact Factor (JIF) rankings for our specific arts and humanities categories would be challenging to interpret and of limited value. Instead, we recommend using JCI rankings introduced in 2021 as the most suitable method for comparing and ranking journals within these categories. Given this, we have decided not to include JIF rankings for arts and humanities categories in the upcoming Journal Citation Reports (JCR) release. This decision aligns with our commitment to providing trustworthy data and responsible metrics. Our focus remains on delivering reliable information that meets the needs of researchers.
