This plan outlines inspections and tests to ensure quality control on a project, as well as serving as a checklist for logging inspection results. Inspection and Test Plans are essential tools for controlling quality in production and service provision, as mandated by the ISO 9001:2015 standard. Both documents must be controlled and maintained as part of the organization's quality management system. In practice, an ITP can be applied at critical points such as "Incoming Goods," where verifying that the supplier has delivered the correct materials is crucial before starting production. By implementing a structured approach to inspections and testing, organizations can maintain consistency in their output and ensure compliance with ISO 9001 standards. Maybe goods cannot be given back to supplier anymore. Minimal review in this case would be examining material certificates from provider, checking dimensions of cut pieces supplied or ensuring part numbers match ordered parts. In construction, next inspection point usually comes after major work is done before covering it up for the next stage. For example, prior to wall lining or waterproofing tiling. Detailed inspection instructions are given in separate checklists like F-12 which lists all necessary documents before site preparation starts. Pre-pour checklist, F-72 has space for rectification records. These documents help resolve later disputes and are crucial project records. Example of an ITP is shown above along with matching checklist which record actual person performing inspection on the day. Checklist also includes values to be measured and accepted ranges like in circuit board assembly inspection. There's a difference between plan and checklist "who" in terms of roles responsible for inspections. Plan mentions who should perform, while checklist records actual person doing it. ITPs are crucial for quality control and belong in quality management systems. There are ways to handle ITPs using Quality Systems Toolbox software like uploading existing documents or creating digital forms and registers. This helps customers evaluate the contractor's ITP by indicating checks done in each work area before and during the inspection.
